Admission Policy

The Missouri Military Academy Leadership Camp admit campers of any race, color, religion and national or ethnic origin to all the rights, privileges, programs and activities generally accorded or made available to other campers.

Campers are admitted upon the expectation that they shall remain in good standing at the Camp until they are excused at its conclusion. Since Counselors, Directors and other staff members are contracted, and other provisions are made in advance for the entire camp, no rebates on Camp Fees will be made when a camper is absent, dismissed or withdrawn before the conclusion of the Camp, regardless of the reason. Leaves from Camp will not be granted.

Admission into the Leadership Camp shall be determined by Missouri Military Academy at its sole discretion, which reserves the right to deny any applicant for any reason deemed appropriate by MMA. It is MMA's policy not to share reasons for an applicant being denied admission.

Special Medical Attention

There will not be charges for minor medical attention in the Cadet Clinic such as the administration of Motrin or application of antiseptic solutions and Band-Aids. Any fees for consultation or special care, charged by physicians or nurses that may be called to assist the Cadet Clinic staff in case of illness or injury of a camper, medicines, and charges for any service or care beyond those of a minor nature, are to be paid by the parent/guardians of the camper concerned regardless of whether such costs are covered by insurance.

Conditions of Admission

All who are accepted into the Leadership Camp must be physically and emotionally able to participate in the active life of the Camp. Admission to Leadership Camp is not final until the Certificate of Health has been received and approved by the Academy physician. The health history must be updated should any changes occur in the applicant's medical/psychological condition after the form is submitted. Any changes must be reported to the MMA Admissions Office. Changes in health history, regardless of how they are revealed, will be reviewed by the Academy physician.

All campers must have required immunizations and a current physical examination (within three months of opening day) prior to final admission. A camper may be denied admission to the Camp or may be required to withdraw if, in the sole opinion of the Academy physician, the camper is unable to (or should not) participate in the active life of the camp from a medical or psychological standpoint.

Recreational/Training Activities

Parents/Guardians agree that this camper may row, paddle boats or ride in boats, ride in buses or Camp vans, ride horses, ride bicycles, use the archery range, swim in lakes or rivers, rappel, participate in the ropes course, fire on the rifle range and participate in paint-ball activities. Some activities may be scheduled at sites away from the MMA campus.

Photo Assignment, Consent and Waiver

By signing this Application/Enrollment Agreement, parent/guardian gives permission to use photo(s) taken of the applicant without limitations in publications, promotions, media releases, videos, newsletters, booklets, etc. of the Leadership Camp.

Chemical/Substance Abuse

Drinking, being under the influence, using, attempting to purchase or possessing any form of intoxicating beverage or narcotic, and/or possessing narcotics paraphernalia, and/or abuse or misuse of prescription or over-the-counter drugs or inhalants by any camper at any time during the camp is expressly forbidden and will be considered grounds for dismissal.

It is the policy of Leadership Camp to test campers suspected of abusing drugs and alcohol. Refusal to take the test will be considered grounds for dismissal.

Statement of Understanding

The undersigned parent/guardian and camper understand and agree to the above, and agree that the camper's admission to and continuing enrollment in the Camp is subject to and expressly conditioned on the camper's compliance with all rules, regulations and policies issued by the Camp, as may be amended from time-to-time. The undersigned camper and parent/guardian understand that failure to comply with any such rules, regulations or policies may result in corrective action, including dismissal from the Camp, to be determined and imposed at the sole discretion of the Camp officials.


Articles of value such as jewelry, etc. are not to be brought to Camp. The Camp will not be responsible for loss due to fire or theft of any personal property.
